## **NOTIFICATION**

NO.FD.SR-III-4-244/2023. In exercise of the powers conferred under Section 23 of the Punjab Civil Servants Act, 1974(VIII of 1974), Governor of the Punjab is pleased to make the following amendments in the Punjab Civil Services Pension Rules, with effect from 02-12-2024:

## **AMENDMENT**

In the Punjab Civil Services Pension Rules, CHAPTER IV- AMOUNT OF ORDINARY PENSIONS, SECTION III-C-FAMILY PENSION, the existing rule 4.10(1) shall be substituted as under:

> "(1) A family pension sanctioned under this rule shall be admissible to the extent of spouse for life or till re-marriage:

> Provided further that in case a Government Servant had more than one wives, the pension shall be divided equally among the widows";
